Zora Neale Hurston's short story is a story of women with different perspective. This revealed the violence toward women and women's resistance toward the construction of patriarchal. The violence was shown by a husband toward his wife in psychological, physical and sexual form. The theory used Beauvoir's theory (2012). The researcher analyzed the problem in feminist approach. Women who experience oppression took the resistance as a form of struggle over their existence as women. It was reflected toward the main character in this short story. This descriptive qualitative research was used in this short story. This method was used for looking at data contexts that were hidden from quotations in a short story. The findings showed that Delia was able to resist her husband named Sykes. Delia sought her freedom by escaping the scandal the cruel treatment of her husband. Delia's action contradicted with patriarchal construction that women had to be submissive and respectful towards men due to the women basically were dependent on men. Feminism appeared in this short story was concerned on women's resistance toward violence experienced in social life in order to get freedom, rights and opportunities as a human.

In the past women were made slaves by men as a desire to satisfy their passions, and if there were women who opposed this there would be physical violence against him. In the past women did not receive an education to develop their insights due to the environment society which upholds the role of male head of household and power over women. The Sweat Short Story told of a woman named Delia facing the hardships of life as a woman who received violence from her husband named Sykes. Delia works as a washer

in the Floridian area. Her husband forbade Delia to wash black clothes so her husband felt ashamed of Delia's work. Sykes did not work because he was only at home like a boss man. Sykes had committed psychological, psychics and sexual violence. Sykes even tried to kill Delia with a snake trap but the plan always failed and was opposed by Delia. Sykes's actions led to resistance by Delia as a form of freedom against Delia. Delia put up a fight against Sykes by ignoring Sykes's life when he was in a difficult and helpless situation. faced various difficulties that she had from her husband during their fifteen years of marriage. Delia in the end defied the rules made by her husband against her by going to seek freedom as a strong and independent woman.

This celebration remembers the events that occurred in the short story Sweat who considers the black people in the 20th century as a marginalized community and were not considered as residents who were equal to white celebration people. This was breakthrough that equalized the rights and obligations of the white people and black people. The celebration is held routinely every year to unite all the diversity and differences that exist between the people of Africa and American society In Harlem. This story was related to feminist theory that refutes the opinion of society in general that women were weak and dominated by men because of the superiority that men have in social life. In fact woman can be independent and have intelligence that cannot be doubted today. She squatted in the kitchen floor beside the great pile of clothes, sorting them into small heaps according to color, and humming a song in a mournful key, but wondering through it all where Sykes, her husband, had gone with her horse and buckboard. (Hurston, 1992, p. 1)

The first data explains the poor life of Delia. She worked hard without stopping to make a living for his family every day even it was a Sabbath day where people went to worship and vacation, the circumstance emphasizes how his struggle to work hard. She ponders his misfortune every day because she has to face many difficulties that she experiences every day. In the real situation woman got treated every day will feel pressured and overwhelmed in him. Woman will feel like a fooled who has to do things she shouldn't do. Bad circumstances force a woman's condition to suffer to work tirelessly and incessantly. This event illustrates the reality that occurs in people's lives.

> "Sykes, what you throw dat whip on me like dat? You know it would skeer me--looks just like a snake, an' you knows how skeered Ah is of snakes." (Hurston, 1992, p. 1)

The second data describes one of Sykes's heinous actions tried to kill Delia with a snake. This shows how Delia was treated unfairly by her husband for those who tried to harm him. This incident shows the mischief and violence in Sykes who oppress Delia to die slowly. Woman that oppressed by man certainly not treated preferentially in their household. She will always be in the wrong position and suffer from the oppression he received by man. This is a form of unilateral oppression which harms a woman. Women basically will

feel pressured if oppressed every day with a situation that is so complicated in front of him.

When dey's satisfied dat dey is wrung dry, dey treats 'em jes lak dey do a cane-chew. Dey throws em away. Dey knows whut dey is doin' while dey is at it, an' hates theirselves fuh it but they keeps on hangin' after huh tell she's empty. Den dev hates huh fuh bein' a cane-chew an' in de way. "(Hurston, 1992, p. 4)

The third data explained how Sykes treated Delia like a weak object and was easy to play. This incident shows the actions of men in general who only want the body of a woman. After he got what satisfies his lust, men will oppress women as he pleases. In fact some men want women only as satisfying lust only. After satisfying his lust, men will treat women roughly with physical violence. This happens because a man feels power over a woman.

Delia's work-worn knees crawled over the earth in Gethsemane and up the rocks of Calvary many, many times during these months. She avoided the villagers and meeting places in her efforts to be blind and deaf. But Bertha nullified this to a degree, by coming to Delia's house to call

fourth quote The describes Delia's distresses and struggles like Jesus figure that carried the burden of the cross of life to atone for the sins of mankind. Before Jesus was handed over to carry the cross, at night Jesus was betrayed by one of his beloved disciples, Judas Iscariot. As well as Delia's life which was full of suffering to carry the burden of her life because it had to be betrayed by her beloved husband. How cruel and humiliating Delia was that Sykes could bear to oppressed his own wife. Delia sacrificed herself to be oppressed and betrayed by Sykes. Woman surrendered to the difficulties he faced at the time also made his mind very devastated by the situation involving him to work hard alone in his married life.

#### 4.2 Resistance of woman

Delia went clear to the rail without answering him. A triumphant indifference to all that he was or did. (Hurston, 1992, p. 3).

In the first quote above Delia began her actions not to care about the circumstances of Sykes. Delia ignored her husband and began planning to rebel the pressure and against sexual harassment she had endured. Delia regained her strength firmly to face Sykes courageously without fear of her husband. As a form of woman resistance she will come out of the oppression of a man to be free and get the happiness he deserves in his life without misery again.

In the second quote above explains how the beautiful appearance of a Delia was abused by her husband with physical violence, but this incident teaches Delia to be a stricter and stronger woman to face the oppression of Sykes. Delia proves with her obstinacy against the form of oppression of a man. Delia rose from the deterioration of her life as

a woman who is super tough. It can be seen from the quotation:

"Too much knockin' will ruin any 'oman. He done beat huh 'nough tuh kill three women, let 'lone change they looks,". (Hurston, 1992, p. 3).

From the quotation it can be clearly seen how Delia resisted the oppression carried out by her husband. All people who experience oppression will certainly be moved to take action. In this case, Delia shows that she is not a weak woman. She is able to be even more violent than men to maintain his existence as a woman. Delia was a strong woman that has been released from the grip of a man who for fifteen years oppressed his freedom to be independent. Her suffering was over because she had fought against her husband. This shows that Delia had ventured to oppose her married life which could no longer be repaired due to the oppression that she experienced.

Delia who was previously represented as submissive, subordinate and even helpless was not entirely correct. Because of the oppression that kept happening to her, Delia was moved and to fight and rebel in other ways. This can be seen from the following quote:

"Well, Ah done de bes' Ah could. If things aint right, Gawd knows taint mah fault." (Hurston, 1992, p. 8)

This quotation showed that Delia who was once a quiet, innocent and submissive woman has now turned into a strong woman to fight and oppose Sykes boldly before her husband on things contrary to Delia's justice. Even when Sykes was dying, Delia really did not care about her husband's condition. This proves that women can oppose men with the right actions to escape the oppression of a man. She took the right action in accordance with the dark events that have been experienced. Delia made up



her mind to believe that he ignored whatever happened to her husband. she did not care how many sacrifices she had done for her husband. Delia felt that her decision not to care about her husband who was being critical at that time would bring them to the end of the separation that would free her from her husband's oppression.

In the conception of the patriarchal construction thought, a man is imaged with the term of "self" and the sense that he can do anything without help from others. The short story turns the fact upside down. Her husband, when he suffering from a serious illness seemed to be a helpless person. Whereas all this time he always oppressed and violated Delia. Off course, Delia who has been oppressed shows that women have dominant power like a men. Delia ignored her husband can also play a subordination position. This can be seen in the following quote:

A surge of pity too strong to support bore her away from that eye that must, could not, fail to see the tubs. He would see the lamp. Orlando with its doctors was too far. She could scarcely reach the Chinaberry tree, where she waited in the growing heat while inside she knew the cold river was creeping up and up to extinguish that eye which must know by now that she knew. (Hurston, 1992, P. 9)

This quotation reflected that Delia really did not care anymore with the current state of critical health. Delia pondered and decided to end their fifteen years of marriage. Delia believes this as a form of resistance against her husband with the oppression that Delia has been getting. This decision was carefully considered by Delia with her Christian beliefs. Ending a relationship is a tough decision for a husband and wife but to

get a fair life for a woman over the oppression that she experienced, this is the right act of resistance that must be taken in the life of a woman to get real freedom.

#### 5. CONCLUSION

Hurston's short story entitled Sweat indicates that perseverance helps to go through the miserable years as represented by Delia Jones's experience of facing her abusive husband, Sykes Jones. Sykes's insecurity as a jobless husband is covered in rudeness, cruelty, and mocks besides having another woman. For fifteen years Delia applies elements of perseverance, such as fearlessness, choice, discipline, clarity, life is life, just like me, and patience. She could survive against Sykes's domestic violence in the forms of physical abuse, psychological abuse, and threats violence. Even Sykes's rattlesnake, through at first has the potential to paralyze Delia due to her fright of snakes, could be overcome by Delia's growing fearlessness and clarity to observe the scary moment. Finally Sykes's arrogance, self-confidence, and evil plan made him be bitten by his poisonous rattlesnake previously set up to put Delia's to death. Delia's was free from her abusive husband at last. Her perseverance led her to a free life in the house she sweated so far to own and keep it. In the real life women were categorized as weak people. But over time the women carried out a movement to raise the degree of women equal to men. Even though many have been challenged and criticized by various groups, women have proven with the hard work and knowledge they have to advance social life today.
