HIROSHIMA CITY CONDITION BEFORE AND AFTER BOMBED BY UNITED STATE AS DEPICTED IN JOHNHERSEY'S "HIROSHIMA" : HISTORICALAPPROACH

ABSTRACT

This research is an analysis of Hiroshima City Condition Before and After Bombed by United States as Depicted in John Hersey's "Hiroshima": Historical Approach. It is research has two specific objectives of this research, first is to find out the problems faced by the people of Hiroshima before and after the bombing. The second are to find out the facts of the historical facts after bombed. The methodology used in this research is descriptive qualitative method. Data would be gathered from primary source, which is the novel Hiroshima, and secondary sources from various sources, such as history books. The analysis of this study applies the historical approach of Hippolyte Adolph Taine (1872) which explains the race, milieu, and moment. The problem of the Hiroshima community before and after the bombing is proven where many of citizens in Hiroshima lived improperly because the condition of economic matters was paralytic. And the condition be apprehensive is many of citizen in Hiroshima died and were permanently disabled. Then historical facts are also found, namely the surrender of Japan on August 15, 1945 which is announced by the emperor Tenno and the construction of a national monument named the Institute of International Amity. With all these facts, the researchers then concluded that Hiroshima, written by John Hersey indeed contained facts about the fear and anxiety of the Hiroshima community before and after the bombings carried out by United States soldiers.

INTRODUCTION

History is an event that happened in the past that was arranged on the basis of various events. According to Carr (1968) history is a dialogue that is never completed between the present and the past, a continuous process of interaction between historians and the facts they have. From the definition above, it can be concluded that history is an event or dialogue that happened in the past that can be proven by facts by historians.

In this case, the historical factor can be studied by using a concept of study that called the historical approach. The historical approach is a study carried out by prioritizing historical factors. According to Russell (1966) Historical approach is one of the method to analyze literary work in which the author and the reader comprehend the message of the literary work by remembering the moment or historic moment a long with the literary work written. It means that historical approach is an activity to analyze a literary work by looking at historical moments in the past that might be written by a writer into a novel.

In this research, researcher chooses Hiroshima novel by John Hersey for Primary source. Hiroshima talks about the story of the sixth main character's struggle above from the bomb blast launched by the American army. Starting from the atomic bomb which exploded in Hiroshima at 8:15 a.m. Japanese time on August 6th, 1945 has become a story of deep sorrow for Japanese citizens. Of the 245,000 inhabitants of the city, nearly 100,000 people were killed or dying in one hit. Although the atomic bomb explosion was very powerful, there

were still Hiroshima residents who survived the deadly bomb, including six people who told activity before and when they saw a white glint without sound. Twelve days after the explosion, strange symptoms appear. Some people experience nausea, weakness, fatigues and hair loss. They don't realize that the pain they experience is the impact of the explosion. A strange disease that is easy to change is hereinafter known as "Radiation Disease".

Based on the background of research above, the researcher has two formulations of the problems noted below:

- 1. What are the problems happen of the citizen of Hiroshima before and after bombed as seen in the novel *Hiroshima* by John Hersey?
- 2. What are the historical facts that found after bombed as seen in the novel Hiroshima by John Hersey?

Based on the formulation above the researcher would be explains the result in this paper. It made the result explain clearly. Therefore, this research focuses on the Historical Approach theory by H.A Taine using novel entitled "Hiroshima" by John Hersey.

RIVIEW OF RELATED LITERATURES

Someone who wants to criticize or analyse a literary work definitely needs an approach to implement a literary work. Every single approach differs from one to another because it is made in accordance with certain literary works. Thus, the focus of each approach is specifically following the respective nature of the applied object.

According to Webster (2017) Historical criticism, literary criticism is a light of evidence or based on the context in which work is written, including facts about the author's life and the historical circumstances of the time. The point is that someone who wants to criticize a literary work must understand the fact of the historical facts in which a literary work was written. Usually the facts cover the life of the author, the history of the region and the social life of the character in the literary work.

According to Walliman (2011) Historical approach is a systematic and objective evaluation and synthesis of evidence in order to establish facts and draw conclusions about past events. It uses primary historical data, such as archaeological remains as well as documentary sources of the past. It is usually necessary carry out tests in order to check the authenticity of these sources.

Based on the above description, it can be concluded that the historical approach is a learning or study of historical factors that occurred in the past as outlined in a novel according to the facts that occurred in the past in accordance with the context.

There are considerable amount of approaches that exist as method of literary critic. Historical approach is one of the lists, a critic that follows the element of the history bearing. It used to analyse history study in a literary work. The usage of historical approach is none other for scoping the aspect of events happened in the past. Historical approach sees a literary work chiefly, if not exclusively, as a reflection of its author's life and times or the life and times of the characters in the work Guerin (2005). This approach is basically an approach where the data gathered are taken from the historical events depicted in the literary work.

There are numerous varieties of historical approach known in literary criticism. The most famous one is the theory of a French philosopher named Hippolyte Adolph Taine (1828-1893). Taine's theory of historical approach is state about three tenets which concise of race, milieu and moment Guerin (2005). Based with its suitable characteristics, the researcher then uses this theory of H.A. Taine to find historical existences occurred in *Hiroshima* by John Hersey.

2.1.Race

There is a lot of understanding about race. According to Webster (2017) race is as a family unit, tribe, and community living in the same environment. So specifically race means innate or offspring brought from birth. According to Taine (1872) race is as innate or hereditary character brought by humans to the world with certain physical characteristics, interests, habits, or certain characteristics. as quoted below in the novel Les Miserables by Victor Hugo;

Montfermeil is a village. This village is a peaceful and charming place, not a route that connects one place to another. In this place the citizens live a simple rural life that is so generous and modest, including Mr and Mrs thenardier. Only water from the past is very difficult because of its high position (page 119)

Based on the quotation above it can be conclude that how the condition of a village that is very peaceful and captivating to its name is Montfermeil village. Where in this place citizens live modestly and a society that is so generous and modest lives includes Mr and Mrs Thenardier master. Based on the previous description, it can be concluded that the condition of a region is very influential on life and the way of life of the community of its citizens.

Based on the theory of Taine (1872) about this race, the researcher will be able to find information about people or places of literary work as outlined in a novel including the study of the descendants of the protagonist family in the story. Then specifically race based on H.A Taine theory is recorded as the following points.

2.1.1 Interest

In general, the notion of interest is attention that contains elements of feeling. Interest is an encouragement or desire in someone on a particular object. According to Taine (1872) interest is a desire that arises from someone to get something, and based on this his believes interest can be the basis for analyzing a literary work such as a novel. Based on the description above, the researcher concluded that interest is a part needed to analyze each part of the story in a novel. The interest taken above can be seen as the quote below:

Charles Darnay and Sydeney Carton are the main characters in the novel A tale of Two Cities. Darnay, which was part of the French aristocracy, experienced self-upheaval and changes in thinking became more humanistic. While Carton, motivated to do penance for what he thinks is inappropriate for the past by sacrificing himself for the happiness of others.

Based on the above quote can be made a conclusion that person can sacrifice soul to fulfill a desire that arises from within someone, as was done by Carton who sacrificed soul to atone for the sins he committed in the past in order to fulfill the desires that arise from within him.

2.1.2 Habit

Habit is an activity carried out repeatedly. According to Taine (1872) habits can be a foundation for someone who wants to study a literary work. For example, a researcher who wants to study a literary work must be able to understand the habitual habits played by someone in the literature that will be studied. For example:

In a Les Miserables novel it is told how the suffering of a girl 7 year old, her named is Cosette. She was forced to do the homework of the employer who should not do the job. Where is every day he had to lift water for the purposes for the Thenardier family.

Based on the quotation above, it can be conclude that how the granting of a seven-year-old girl separated from her parents is called Cosette. Where in the middle of his age, she was still seven years old and was supposed to play with his friends, but this did not materialize she was even forced to work to lift water for

the purposes of the Thenardier family. Based on the description it can be concluded that the habits carried out every day will feel light if it has become a necessity.

2.2.Milieu

Milieu has many definitions. In its broad sense milieu means as the physical or social setting in which people live or in which something happens or develops Webster (2017). Milieu in Taine's theory of historical approach means as the relationship of an object to its surrounding or environment. It can be rebuilt by analysing social background such as family descendent, occupation, relatives, neighbourhood Taine (1872). Milieu of Taine explains about the surrounding of a character in their respectable time of existence in a certain environment'. Thus, milieu is the tenet that scopes about what kind of environment the story takes place.

2.2.1 Profession

Profession is one that can be classified into the theory of Taine, because work is a person's relationship with their environment. It is means that profession is a job that requires training and mastery of certain knowledge. Or the profession is also often interpreted as work that requires special training and expertise. So the work done by someone can be seen from the expertise mastered. For example is the quote below from the novel tale of two cities by Charles Dickens.

At one time the Monsieur Defarge saw a whitehaired man bending and working on sewing a shoe. it turns out the old man is Monsieur Manette. Then Monsieur Defarge says it looks like you are not a shoe tailor, but Monsieur Manette denied that I was not a tailor in the past because of the effort and hard work to learn and practice finally I could sew perfectly.

Based on the quotation above, it can be concluded that how a person can become a professional worker is influenced by his own environment. If someone previously can't do anything, but if he lives in an environment where the majority has a profession as a shoe tailor, at least someone can make shoes for himself.

2.2.2 Social

Social life cannot be separated from an environment because every environment must have a social life. Social life is explaining about social interactions in the environment Taine (1872) . Social life is a life in which there are social / social elements. A life is referred to as social life if there is interaction between one individual and another, and with it communication occur which then develops into mutual need for others. According to Pratiwi (2012) social life is a human life association of various types of groups formed through different social interactions in people's lives. For example:

At one time there was a family who was very rich but very arrogant, did not want to integrate with the people around him. But over time he experienced his house on fire, he begged for help but none came. Over time the fire was extinguished and he only realized that treasure could not do everything and he thought social life was far more important than a pride.

Based on the example above it can be concluded that humans cannot be separated from social life to integrate in their own environment. Social life is also a way to exchange ideas with other people to open up broader insights when meeting a problem.

2.3.Moment

Moments can be classified as the core of events told in literary work such as novels. According to Webster (2017) moment is the point or time at which an event occurs. The point is that in a literary work the thing that must be known is the moment that occurs in the literary work, especially the novel. Because the moment is as a starting point where an event begins and ends. Thus, if a researcher in a literary work has mastered all the series of events in the literary work, it will be easier for researchers to find the data needed specifically about Historical Fact.

According to Taine (1872) moment that is recorded and occurs in a certain time. It is a component of the measuring system used to see a sequence of events in history. Based on this understanding the researcher can conclude that literary work is a series of events that occurred in the past in a certain time. Based on the explanation, the researcher wanted to briefly explain the moment moments contained in the Les Miserables novel by Victor Hugo, as described below.

2.3.1 Revenge

This stems from the anger of a former inmate named Jean Valjeans who was sentenced to 19 years for stealing a cake to reduce his hunger. After he left he wanted to eliminate the people who had betrayed him. But his intention was not carried out because a very good bishop reminded him of the meaning of kindness and honesty, the bishop was Monseigneur Bienvenu, and with this incident Jean Valjeans also changed his name to Monsieur Madeleine.

2.3.2 Resurrection

After Jean Valjeans changed his name, and with the advice capital given by the bishop he slowly began to organize a new life. Over time his life has begun to improve and arguably he is already well off because of the hard work he has built, Jean Valjean's can set up factories and open jobs for people around him. It wasn't until Jean Valjean became the richest person in the city and made him the mayor.

2.3.3 Honesty

After Jean Valjean was on the verge of glory, he was confronted with a problem where someone named Champmathieu was suspected by the court as Jean Valjean, a police fugitive. Knowing this, Monsieur Medeleine was overwhelmed by confusion, whether he had to admit who exactly was to the court to save Champmathieu or whether he was still hiding behind the greatness and kindness of Monsieur Madeleine's name. But in the end the honest nature that had been instilled by the bishop made him admit who he was, and he admitted that he is Jean Valjeans.

Thus, based on the description above the researcher can be concluded, the moment is a series of events arranged in such a way in a literary work to attract readers, because a reader will feel curious what will be caused by every moment that occurs in the story. So the moment is the starting point for developing a paper, especially a novel.

METHOD OF RESEARCH

3.1 Research Design

Research design is an early strategy to conduct a study. According to Creswell, (2014) says that research design is the type of inquiry within qualitative, quantitative, and mixed methods approaches that provide specific directions for the procedures in a research study.

Research has more than one form of formulation, which focused in its respective specified cases. Conventionally, the widely used research in solving a literary based problem is a method called as qualitative research. Qualitative research itself is a method of research which purpose is a study to describe a situation, phenomenon, problem or event; and establish the variation in the situation, phenomenon or problem without quantifying it Kumar (2011).

Based on the expert theory above, the researcher uses qualitative descriptive research in order to find out problems of Hiroshima city people before and after bombed and the historical fact as found in the Hiroshima novel by John Hersey. Data gathering is using observation by non-participatory method and taken from the novel itself as the primary source and criticism of the novel and other sources related to the novel as the secondary source, such as the history books.

3.2 Object of the Research

Object of the research is the problem analyzed by the researcher. The object of the research is the Hiroshima city condition before and after the bombed and Historical facts after bombed in the novel "Hiroshima by John Hersey. The researcher also uses additional sources to support the analysis for the historical events illustrated in the novel, such as the history books.

3.3 Method of Collecting Data

According to Lofland (2006) there are two methods of colleting the data, there are primary data and secondary data. Primary data is the main source of the research and secondary data is the additional information and source which support the research. In this research, the researcher uses observation as the method of collecting data. The researcher uses novel "Hiroshima" by Victor Hugo as primary data source. Secondary data source is normally used to provide the writer material such as related theory and any relevant information to be attached in the research. Secondary data source is all of printed media or article which is related to this research. In this research the secondary data source are taken from book and journal which related to this research.

3.4 Method of Analyzing Data

In this part, there are two components that will be discussed, intrinsic and extrinsic component. Intrinsic components refer to the internal factor of the literary work which consists of some element of fiction. According to Minderop (2010) intrinsic elements are the elements that build the literary work itself. In general, the intrinsic elements of fiction are plot, character, setting, theme, and point of view. In analysis extrinsic component the researcher analysis the data by using some procedures;

- 1. Reading "Hiroshima" novel intensively.
- 2. Identifying and selecting the data based on historical fact.
- 3. Analyzing the selected data by using Hippolyte Adolphe Taine theory.
- 4. Explaining every levels of historical approach base on the novel.
- 5. Making a conclusion based on the data analyzed.

3.5 Method of Presenting research Result

According to Creswell (2014) there are two methods of presenting the research result, formal and informal. Formal method is present the result data by using symbol, signs, table, and diagram and informal method is present the result data by using words or sentences. In this research, the research uses informal method to present the research result. So, this data want to be reported descriptively by using words and sentences and supported by all of qualitative data.

RESEARCH ANALYSIS AND FINDING 4.1Before Bombed

Hiroshima was one of the most developed cities before the bombing on August 6th, 1945.Beside that, this city was once used as a place to manufacture Japanese weapons.

4.1.1 The Life of Citizen in Hiroshima before the Bomb Dropped

The living conditions of the citizen before the Hiroshima bombing were very uneasy, every day people were always worried that Hiroshima would be bombed because there were at least cities in Japan that had not been attacked. This can be seen in the quote below.

Mr. Tanimoto, like all his neighbors and friends, was almost sick with anxiety. He had heard uncomfortably detailed accounts of mass raids on Kure, Iwakuni, Tokuyama, and other nearby towns; he was sure Hiroshima's turn would come soon. He had not slept badly the night before, because there had been several air-raid warnings. (Jhon Hersey, Page: 2)

Based on the quotation above, it can be seen that how the anxiety of citizen in Hiroshima before the bomb was dropped. This matter was also felt by Mr. Tanimoto where he felt the anxiety every day because he already knew that Hiroshima will be bombed. This incident made Mr.Tanimoto could not sleep calmly because the air strike warning was always launched. Thus, Based on the

description before also can concluded that the tranquility of a region is very influential on how to think of someone. Which means to make a harmonious society must be supported by a safe and peaceful region.

The social life of citizen in Hiroshima was also seen harmonious before the bomb dropped. This was shown by a sense of mutual care for others especially when someone is in trouble and they help each other. It happens because they believe social life is very important in a society especially in the midst of an uncertain region. This was indicated as quote below.

Besides having his wife spend the nights in Ushida, Mr. Tanimoto had been carrying all the portable things from his church, in the close-packed residential district called Nagaragawa, to a house that belonged to a rayon manufacturer in Koi, two miles from the center of town. The rayon man, a Mr. Matsui, had opened his then unoccupied estate to a large number of his friends and acquaintances, so that they might evacuate whatever they wished to a safe distance from the probable target area (John Hersey, Page 2)

Based on the quotation above, it can be seen how good social life is in the middle of Hiroshima society. This can be seen of the concern Mr. Matsui to his best friend Mr. Tanimoto. Where he had provided a house for storing valuable items from Mr. Tanimoto's place and he chose a house far from the target of the bombing. Thus, the region can be seen from the way people help each other, especially when in trouble. The point is when someone who gets trouble attention from someone, this will cause a new spirit for that person.

Social life is very important for every persons, this can be seen in quote below base on Hiroshima novel by John Hersey

In compensation, to show himself publicly a good Japanese, Mr. Tanimoto had taken on the chairmanship of his local Tonarigumi, or Neighborhood Association, and to his other duties and concerns this position had added the business of organizing air-raid defense for about twenty families.(John Hersey, Page 3)

Based on the quotation above, it can be seen that everyone really needs the attention of someone. This matter was also felt by Mr.Tanimoto where he felt people's suspicion towards him. This situation made Mr.Tanimoto unable to think calmly because of the suspicion of the people around him. Thus, to restore credibility and suspicion Mr. Tanimoto has planning to become the head of *Tonarugumi* (Chairperson of the Household). Thus, based on the description before, it can also be concluded that the calm of someone mind is strongly influenced by social life in that environment. Which means to create a smart mind must be supported by a harmonious social life.

4.1.2 The Condition of Hiroshima City before the bombed dropped

The city of Hiroshima is one of city very developing and has strategic location. The city of Hiroshima also became a very developed economic center because there were many factories that opened jobs for the community. This can be seen from the quote below base on Hiroshima novel by John Hersey.

Factories and other residential districts, or suburbs, lay compactly around the edges of the city. To the south were the docks, an airport, and the island-studded Inland Sea. A rim of mountains runs around the other three sides of the delta. Hiroshima is a city in a strategic region that is growing rapidly (John Hersey, Page 4)

Based on the quotation above it can be seen that how the condition of the city of Hiroshima which was so developed and advanced before the bombing on August 6th, 1945 at 8:15 a.m. This city has many industrial plant factories, ports, airports, and is surrounded by small island islands that make this city beautiful. Thus, based on the description before, it can be conclude that a country or city who has a safe location and strategy will have a positive impact on the lives of its people, it means that the best country will support a better life for the community. Thus, that it will create an environment that is peaceful, harmonious and prosperous.

4.1.3 The Economy People in Hiroshima City before the Bomb Dropped

The economy of the Hiroshima community before the bombing began did not work as a developing city. This can be seen from the public's fear of the issue of bombing which resulted in them not working optimally. This was also felt by Mrs. Nakamura, as stated in the quote below which is written in the Hiroshima novel by John Hersey.

After her husband's death died, he stopped and stopped, Mrs. Nakamura took out the sewing machine and began to receive stitches. Since then, he paid for his three children from sewing. His income was certainly not enough for four people. They live in a rough way (John Hersey, Page 7)

Based on the quotation above it can be seen that how the struggle of a mother to support her three children, they are Tosio, Myeko, and Yaeko in the midst of a city that is not safe. After the pair arrived from her husband, Mrs. Nakamura was forced to live a rough. However this did not discourage Mrs. Nakamura from losing her sewing machine to support her three children. Thus, based on the description before it can be conclude that in life there is no word of despair and never give up, still giving the best and always have a sense of optimism to do something. Where someone will do everything to fulfill their life, especially psychological needs.

The condition economic between someone with others will never be the same. This is also the same as the community in the city of Hiroshima. Like Dr. Fujii, he is one of those who has an established economy, as quote below

This porch in fact, the whole building was curiously constructed, Dr. Fujii was the proprietor of a peculiarly Japanese institution: a private, single-doctor hospital, This building, perched beside and over the water of the Kyo River, and next to the bridge of the same name, contained thirty rooms for thirty patients and their kinfolk.(Jhon Hersey, Page: 8)

Based on the quotation above, it can be seen that how the condition economy of Dr. Fujii is very wealthy. He was owner of a typical Japanese institution. In addition, he also owns a private hospital. This hospital is very beautiful because it was built on the Kyo river and not far from the bridge. This hospital employs one doctor and several nurses. The hospital also provides thirty rooms for thirty patients and their families. Thus, based on the description before can be conclude that the economic life is important to make someone able to continue his life normally. But, after someone has enough economy, the thing that is not less important is to care for the people around him.

4.2 After Bombed

The city of Hiroshima experienced an event that could not be forgotten of the people in Hiroshima where exactly on August 6th, 1945 the city of Hiroshima was bombed by American soldiers. Where, the condition of the city which was originally so beautiful and its economy is prosperous. In this section the researcher wants to describe the condition of society, city and economy in Hiroshima after being bombed by an atom by the United States written in John Hersey's Hiroshima novel.

4.2.1 The healthy condition and life of Citizen after the Bomb Dropped

Social life is the most important thing in all situations. Where, if someone has a good social life, it will be easier for someone to get a solution from the problem that is being faced, this is the same as the citizen in Hiroshima, where each other helps each other to save themselves from bombs detonated above the city of Hiroshima, this can be seen from the quote below.

The hospital was in horrible confusion: heavy partitions and ceilings had fallen on patients, beds had overturned, windows had blown in and cut people, blood was spattered on the walls and floors, instruments were everywhere, many of the patients were running about screaming, many more lay dead. (Jhon Hersey, Page: 13)

Based on quotation above it can be seen that how the chaos and damage caused by bombs was dropped by

American soldiers in the city of Hiroshima. It is consequence of this bombardment caused the hospital room to fall apart and to level the ground. However, there were not many of the patients who were in the hospital room injured, not even a few of them died. Thus, Based on the description before can conclude that confusion or damage to an area can quickly influence someone thinking. This happens when a person is faced with a disaster to save himself, for example the victims of the Hiroshima bomb who fought as hard as possible to escape the ruins of the hospital. The most important point is that every disaster or chaos cannot be predicted when it will come, but every human being must prepare something to deal with this situation.

In addition to the quote above there are also things that state how the effects on the community that have occurred as a result of the bomb are dropped, as quote below.

> attached himself sympathetically to an old lady who was walking along in a daze, holding her head with her left hand, supporting a small boy of three or four years old on her back with her right, and crying, "I'm hurt! I'm hurt! I'm hurt!" Mr. Tanimoto transferred the child to his own back and led the woman by the hand down the street, which was darkened by what seemed to be a local column of dust. (Jhon Hersey, Page:16)

Based on quotation above it can be seen that Mr. Tanimoto to help an old woman who walks like a dazed person. Where effect of the bombed was made the woman carried a boy the age of four years old and he was seriously injured. when Mr. Tanimoto seen this fact he try to carried the child to be able to guide the two persons out of thick lumps of dust without think about his wound. Thus, from description before can be concluded that caring for others is something that is needed in living a social life. It is imperative that every social being must help one another. If someone has the ability to help others, then someone must do it.

Difficulty of life is a thing or event that is difficult to deal with. But all that can be dealt with enthusiasm to help each other. This can be seen in the citizen of Hiroshima in the midst of bombings, but the sense of care for someone that needed helped to stay awake, this case can be seen as quote below.

Just then, the two other priests living in the mission house appeared—Father Cieslik, unhurt, supporting Father Schiffer, who was covered with blood that spurted from a cut above his left ear and who was very pale. Father Cieslik was rather pleased with himself, for after the flash he had dived into a doorway, which he had previously reckoned to be the safest place inside the building, and when the blast came, he was not injured. (Jhon Hersey, Page: 19)

Based on the quotation above it can be seen that how caring of Pastor Cieslik who was helped Pastor Schiffer.

He was seriously injured as a result of the bombing. The condition of Pastor Schiffer's was covered in blood. He must be got medicinal treatment but the condition of the city like this make Pastor Cieslik lost idea to help his friend to get medicinal treatment. But Father Cieslik is still grateful he was not hurt. Finally he brought his best friend home to a doctor.

Beside that the above events experienced by the citizen of Hiroshima, the effects of the bombings, the following events were also witnessed by Mr.Tanimoto as quoted below.

Mr. Tanimoto's way around the fire took him across the East Parade Ground, which, being an evacuation Area, was now the scene of a gruesome review: rank on rank of the burned and bleeding. Those who were burned moaned, "Mizu! mizu! Water, water!" Mr. Tanimoto found a basin in a nearby street and located a water tap that still worked in the crushed shell of a house, and he began carrying water to the suffering strangers. When he had given drink to about thirty of them, he realized he was taking too much time. (Jhon Hersey, Page: 29)

Based on quotation above it can be seen that after bombed, the fire appeared in various locations, including the East Parade Ground, which was designated as an evacuation site. However, when Mr. Tanimoto is passes many of the citizens who have burns and bleeding and not a few of them want to take water because of thirst. Afterwards with all his might he try to brought the water to reduce the thirst of the injured of citizen.

Thus, based on the description above, it can be concluded that to pass through a life of every person needed in a safe, healthy and peaceful region. But sometimes all of this is very difficult to find and if it is not obtained, one must continue to struggle and give the best to live life like the citizen in Hiroshima. which when the condition of the newly bombed city made them many injured, died, starved and thirsty as seen by Mr. Tanimoto at the East Parade Ground refugee camp. However they did not despair and they helped each other to cause a spirit of not despair.

Food and drink are the main things needed by someone body. But this is difficulties to obtain by the bombers launched by the United States. This was experienced by Father Kleinsorge, which can be seen in the quote below.

At the mission, where Mr. Tanimoto left the party, Father Kleinsorge was dismayed to see the building razed. In the garden, on the way to the shelter, he noticed a pumpkin roasted on the vine. He and Father Cieslik tasted it and it was good. They were surprised at their hunger, and they ate quite a bit. They got out several bags of rice and gathered up several other cooked pumpkins and dug up some potatoes that were nicely baked under the ground, and started back.(Jhon Hersey, Page:37)

Based on quotation above, it can be seen that the bombing did not only destroy the building but more than these condition. Such as pastor Kleinsorge who lost all food supplies at his house. But in the midst of the condition of the city like this there is no reason to reject a food that can eliminate hunger. Where at that time Father Kleinsorge did something that could eliminate hunger and he found pumpkins, potatoes, and a few bags of rice. Finally he and Father Cieslik cooked it to relieve the hunger.

Thus, based on the description above it can be concluded that someone will do anything to fulfill their physical needs such as eating and drinking. Which if someone will not be able to think intelligently if his physical needs are not met. This is the same as that experienced by Pastor Kleinsorge who lost his intelligence and strength because he felt hungry. But he did not despair and kept trying to get food in order to reduce his hunger by digging a few potatoes and taking a roasted pumpkin with the effects of the bombing.

4.2.2The Condition of Hiroshima City after the Bomb Dropped

The city of Hiroshima was a region that was highly developed in Japan before being bombed by American soldiers on August 6th, 1945. But after being bombed the city was so broken and falling apart. As for the effects of this bombing, the function of the government was totally paralyzed, the public facilities were falling apart, and the air was already polluted. This can be seen in the quote below.

From the mound, Mr. Tanimoto saw an astonishing panorama. Not just a patch of Koi, as he had expected, but as much of Hiroshima as he could see through the clouded air was giving off a thick, dreadful miasma. Clumps of smoke, near and far, had begun to push up through the general dust, He wondered how such extensive damage could have been dealt out of a silent sky; even a few planes, far up, would have been audible. (Jhon Hersey, Page: 16)

Based on the quotation above, it can be seen how damaged the city of Hiroshima was caused by a bomb dropped. At that time Pastor Tanimoto left the house and almost did not believe, because the incident was so fast and the effects were so severe around the city of Hiroshima. Which this incident have resulted in the air in the city of Hiroshima becoming unhealthy, because the air carries thick and poisonous dust which makes many people who experience sore throat and shortness of breath. Thus based on the explanation before, it can be concluded that in order to obtain good health, it must be in a healthy environment, consisting of green trees, not a barren area and without vegetation, so the important thing for every human being is to always protect the environment to stay healthy and comfortable.

The effects of the bomb not only affected health but also many other facilities in the city of Hiroshima that could not be used. This was seen directly by Pastor Kleinsorge as quoted below.

Father Kleinsorge turned to Father LaSalle and said, "We have lost all our possessions but not our sense of humor." The street was cluttered with parts of houses that had slid into it, and with fallen telephone poles and wires. From every second or third house came the voices of people buried and abandoned, who invariably screamed,(Jhon Hersey, Page:26)

Based on the quotation above it can be seen that how the effects of the bombs dropped by American soldiers were witnessed by one of them by Pastor Kleinsorge. Where the effect of this bomb communication network in this city was severely broken down due to the large number of cable mast poles and downed telephone that filled the road in the city of Hiroshima at that time.

Thus, based on description above it can be concluded that the disconnection of communication networks will result in a new problem, where people who experience this will feel anxious because they cannot know the news from their families. When conditions like this, the only thing that can be done is to struggle to keep up the spirit and never give up.

The phenomenon of bombing in Hiroshima is an unexpected event at the time. After the bombings many experts calculated the losses caused by the event, one of which can be seen as the quote below.

The statisticians' figures on property damage were more reliable: sixty-two thousand out of ninety thousand buildings destroyed, and six thousand more damaged beyond repair. In the heart of the city, they found only five modern buildings that could be used again without major repairs. (Jhon Hersey, Page: 75)

Based on quotation above it can be seen how the effect of bombed to Hiroshima. Which based on the statistical calculation caused by the bombing is that sixty-two thousand buildings were destroyed and six thousand buildings were severely damaged from ninety thousand existing buildings. Based on these circumstances someone can imagine how the destruction of Hiroshima. But behind that there are still five modern buildings that have not experienced significant changes. Thus, based on description before, it can be concluded that how the effect of bombing has destroyed all of the cities that have been growing rapidly. It is can be seen from the large number of citizens in Hiroshima losing their families and residences.

4.2.3 The Economy of Hiroshima City after the Bomb Dropped

The bomb dropped over the city of Hiroshima also caused the economy to be paralyzed. Even though everyone certainly understands the economy is a very important thing to continue life. But it is not enjoyed by the people of Hiroshima, because their source of income has fallen apart, this can be seen as quoted below.

By now he was accustomed to the terrible scene through which he walked on his way into the city; the large rice field near the Novitiate, streaked with brown; the houses on the outskirts of the city, standing but decrepit, with broken windows and disheveled tiles; and then, quite suddenly, the beginning of the four square miles of reddishbrown scar, where nearly everything had been buffeted down and burned. (Jhon Hersey, Page: 61)

Based on the quotation above it can be seen that how the condition of the Hiroshima region after the bombing. Where, the expanse of rice fields that are the source of people's lives has turned into a brownish color, which describes the destruction of life in this city. Many of the buildings whose windows were broken and the tiles were shattered. Even Pastor Kleinsorge found an area of teen square meters containing a brownish wound. Thus, based on the description before can concluded that the condition of a region that has changed drastically can influence the economy of its people. It means that to sustain a better economic life in an area in addition to human resources must be supported by natural resources.

4.3 The Historical Fact after the Bomb Dropped

After the bombing in the city of Hiroshima, there was an event that was abandoned which made this as historical evidence, where the war ended on August 15, 1945 after the Emperor Tenno announced a notification through a radio station as quoted below.

When they came to realize the fact that it was the Emperor, they cried with full tears in their eyes. "What a wonderful blessing it is that Tenno himself call on us and we can hear his own voice in person. We are thoroughly satisfied in such a great sacrifice." When they came to know the war was ended that is, Japan was defeated, they, of course, were deeply disappointed, but followed after their Emperor's commandment in calm spirit, making whole-hearted sacrifice for the everlasting peace of the world and Japan started her new way," (Jhon Hersey, Page: 59)

Based on quotation above it can be seen that how the happiness of society, although many of them cannot stand up and not even a few of the citizens must be exposed because they have no energy to walk. After more than a week Hiroshima was bombed, finally the voice was directly from the Tenno Emperor. Where on that day Emperor Tenno announced a historical fact in which Japan had to be the war of many lives having been lost.

Thus, based on the description before, it can be concluded that someone will be sacrifices his life for the independence of his country. This can be seen from the struggle of citizens in Hiroshima to be free from bombings launched by the United States, even though in the end Japan had to surrender. It was in accordance with

Emperor Tenno's order via radio on the grounds to avoid more victims.

Every event that happens in a nation will usually leave historical facts that will be always remembered during the journey of the nation itself. It also happens in Hiroshima which left historical facts like the quote below.

The Planning Conference, at a loss as to just what importance Hiroshima could have, fell back on rather vague cultural and paving projects. It drew maps with avenues a hundred yards wide and thought seriously of erecting a group of buildings as a monument to the disaster, and naming them the Institute of International Amity. (Jhon Hersey, Page: 74)

Based on the quotations above, it can be concluded that how the conference was described on a map. Where the first thing to do is to build a wide road and no less important is the construction of a disaster monument as a reminder for the history of the city, which ultimately named monument as the Institute of International Amity. Thus, based on the previous description, the citizen must understand and always study the history of their nation to achieve independence, because it is very important to make someone appreciate the services of the nation's heroes.

4.4 Finding

Based on analysis above the researcher found some problems related to condition of citizen in Hiroshima. According to Taine (1872) a literary work criticism specifically about history must have elements of people live at a certain time when the event is occurred. Based on this research with Taine (1872) theory, the researchers found the fact that the bombings carried out by the United States influenced the activities of Citizen in Hiroshima. The first is the life of citizen in Hiroshima can be seen that how anxiety of Mr. Tanimoto where felt that Hiroshima will be bombed. The second are the condition of Hiroshima city can be seen that how damaged the city and the air becoming unhealthy in Hiroshima effect of bombed. The third are the economy in Hiroshima can be seen that the destruction of the economic center in Hiroshima was one of the destruction of the East Asia Tin Work company.

Afterwards the finding of this research is supported by Windasari (2007) research. She also found that are some social effects of the atomic bomb explosion through the Hiroshima novel. There are the changes of the social class, the economic condition, the education, the radiation sickness, the rise of nationalism and the rise of hatred toward the American. The study she also found that the bomb caused a social class, economy condition, and education for citizen in Hiroshima. Thus, it can be concluded that bombing carried out by United States on August 06th, 1945 has launched a social effect on the society itself and has also caused problems to citizen in Hiroshima that are the life of citizen in Hiroshima, the

condition of Hiroshima , and the economy of citizen in Hiroshima.

Then the researchers also conducted research of historical facts contained in the novel Hiroshima by John Hersey with Taine (1872) theory. According to Taine (1872) historical it is a series of events that happened in the past that were emulated with a certain time and have historical facts until now. Based on the Taine (1872) theory the researcher also conducted research on the facts of historical facts in the Hiroshima novel. Where in the study researchers that found two historical facts. The first is when Emperor Tenno made a decision on August 15th, 1945, announcing that Japan was the losing party to avoid increasing the number of victims. The second are building a monument as a reminder. From Japanese history called the Institute of International Amity.

In fact, the finding of this research is supported by Fazbar (2017) which also talk about historical facts related to the political system of Stalinism on the novel Animal Farm by George Orwell. Which in the study he found facts of historical facts one of his result that an infamous political ideology existed in the age of Joseph Stalin. It was a dilapidated ideology that had destroyed its own society in the past. Thus it can be said that the historical facts will be found in a situation that actually happened in the past and still has an effect until now. One of them happened at the events of the Hiroshima city bombing on August 6, 1945 by the United States. To recall this event, the Japanese government at that time built a struggle monument named the Institute of International Amity.

CONCLUSION

Based on the research in the novel Hiroshima by John Hersey researcher found the fact that the bombings carried out by the United States influenced the activities of Citizen in Hiroshima. The first is the life of citizen in Hiroshima can be seen that how anxiety of Mr. Tanimoto where felt that Hiroshima will be bombed. The second are the condition of Hiroshima city can be seen that how damaged the city and the air becoming unhealthy in Hiroshima effect of bombed. The third are the economy in Hiroshima can be seen that the destruction of the economic center in Hiroshima was one of the destruction of the East Asia Tin Work company.

After that the researcher also examined the historical facts contained in novel Hiroshima by John Hersey. The researcher found that two historical facts. The first is when Emperor Tenno made a decision on August 15th, 1945, announcing that Japan was the losing party to avoid increasing the number of victims. The second are building a monument as a reminder. From Japanese history called the Institute of International Amity.

Based on the two findings of the research in the Hiroshima novel by John Hersey, it can be concluded that there are several problems faced by Citizen in Hiroshima that are social, economy, city, and healthy. In addition, researchers also discovered historical facts, namely the surrender of Japan on August 15, 1945 and the construction of a monument that was named the Institute of International Amity.
